### **GUIDELINES FOR RENEWAL OF SHDF SCHOLARSHIPS (2021)**

### **Procedures**

For renewal of SHDF SCHOLARSHIPS 2021, the students are required to submit duly filled in College Report (Format for the same is attached herewith) along with latest Original Income Proof, Photocopy of DMC or Self-attested copy of gazette of last semester's/year's result (**but before Jan.,** 2021) and photocopies of fee receipts for the last year (see details below) **LATEST BY** 30<sup>th</sup> September, 2021

It may also be noted that each student eligible for Renewal of Scholarship will have to attend all Seminars / Workshops when invited for his/her improvement of Communication skills, Personality Development, Moral Science, Human Values and Career Guidance during the year.

Please note that appearing in work shop is mandatory. If you have some valid reason for Non appearing, email us with sufficient proof well in time otherwise penalty will be imposed.

Candidates will also be required to appear for Interview. This interview shall be based on the subject matter contained in the recommended book "Naitik Sikhya" (prescribed by Guru Gobind Singh Study Circle, Ludhiana), General Knowledge and about content of the course for which scholarship is to be paid.

The Interview shall be conducted at different centres (convenient to the applicant) say Amritsar, Ludhiana, Chandigarh, Faridkot, Bathinda, Moga, Hoshiarpur, Shahbad and New Delhi on the date and time will be intimated later on by e-mail or can be checked at Nishkam's website <a href="https://www.nishkam.org">www.nishkam.org</a>
